Footnotes

- 1. Required when the 4th character of the TOS field on the LSR Form = R and the LNA field on the RS Form is N or V.
- 2. PIC only required when ordering InterLATA service: LPIC must = NONE.
- 3 .LPIC only required when ordering IntraLATA service, PIC must = NONE
- 4. Test calls should be performed to each telephone number that is being used as a Remote Call Forward number. This will verify the routing of the call and if you should use 7 digits (555-1212), 10 digits (304-555-1212
- 5. Service and Equipment Code required when additional paths are requested. Example: GSZ 1 for 1 additional path/GSZ 2 for 2 additional paths)

 ***Note use appropriate Additional Path code per State/Tariff
- 6. The listed address must be the address of the terminating number (CFN).
