## **Description of Network Change:**

**Ziply Fiber** announces that it that it intends to retire copper facilities serving in the following wire center located in the state of Oregon

ORIENT OR SE 282<sup>nd</sup> Ave ORNTORXA

The specific affected customer locations are listed in **Attachment A**. Due to a development project, Ziply Fiber is required to remove and relocate its facilities and equipment located east of 282<sup>nd</sup> Ave between Chase and Salquist Rd in Gresham, OR. Ziply Fiber currently has a fiber network infrastructure available to serve existing and future customers. All copper facilities to be retired and removed from the records. Implementation to begin within 30 days of being deemed final pursuant to the FCC notice.

## **Description of Reasonably Foreseeable Impact of the Changes:**

For the locations reflected in **Attachment A**, Ziply Fiber will (1) no longer offer services over copper facilities; and (2) cease maintaining the copper facilities. There are presently 12 total working locations, none of which is a competitive carrier circuit.
